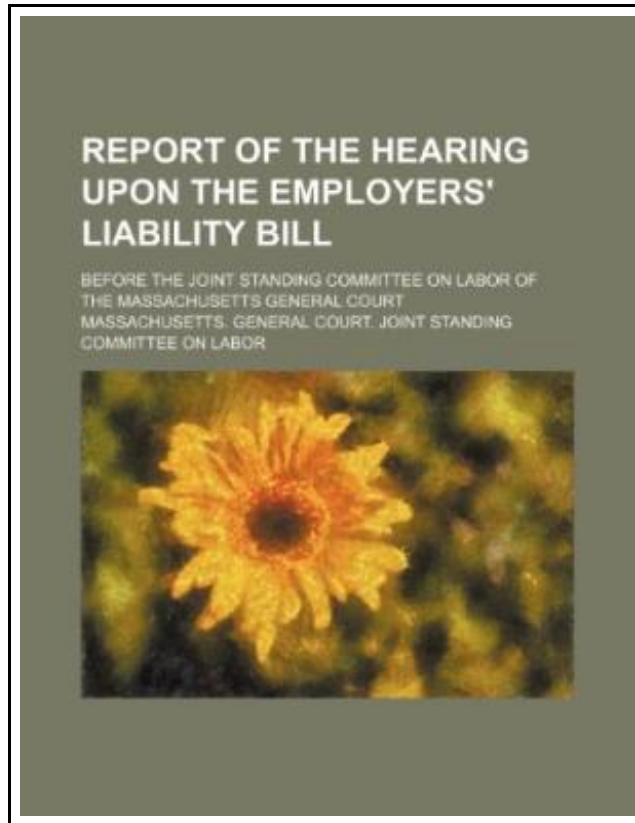

Again, if a staging is put up on any building in the process of construction, workmen are employed on that staging, and it falls; passers-by who are injured can get damages; but nobody who is at work on the staging can get damages, although the...
